



Applicant claims that he was working as casual worker in year 2007, however he has not mentioned the date of his last working day in this office. Information regarding hiring of casual workers during the period 2007 is not available in this office. Contractual/Casual workers are hired through a thirty party agency. As per the Government's guidelines, record of such contract are weeded out after five 5 years. 2. Appointment/promotion/pay related matters of <i>other employees of the Govt. of India, New Delhi</i> can be accessed at DoPT and concerned Ministries/Departments website.






